# Policy Updated 02/04/2025

## **SAFETY & GENERAL RULES**

The following rules and guidelines will be enforced at each and every event, irrespective of the nature of the event. Members, Organizers, Participants and Registered Attendees, Volunteers and Practitioners are all expected to abide by all rules and guidelines including written and/or posted rules of Center of Sarasota LLC, and everyone agreed and consented to signing the waiver. Everyone must abide by all instruction from staff, medical personnel, and event volunteers. Participants, Registered Attendees and Volunteers understand that some events are potentially dangerous and everyone assumes full responsibility for any and all medical expenses incurred as a result of participating in or attending an event. The Center of Sarasota will be held harmless of any claims or legal procedures.

**Right of Refusal**: Promoters, Venue Owners, Venue Management, Security, Event Staff, and other agents of the event, have the right to refuse entry to any ticket-holder, without a refund, for any reason at their discretion, including but not limited to: disorderly behavior, failing to comply with the rules of the venue, incorrect attire, intoxication, venue capacity, breach of security, and other restrictions that may be applicable within reason.

**Enforcement & Removal:** Center of Sarasota Crew and Staff and/or medical personnel and Law Enforcement reserves the right to remove any Member, Participant, Registered Attendee, Practitioner or volunteer from the event for any of the reasons listed above. Medical personnel on site reserve the right to examine any guest/patron who appears to be injured.

**Indoor & Outdoor Events:** In participating in any event held at the Center of Sarasota, all participants agree that they are aware of any potential dangers and accept all inherent risks associated with the event. Any situation that could compromise anyone's safety, should be reported immediately! Urinating or defecating near the building or anywhere on property is strictly prohibited.

**Refund Policy**: Tickets to Events hosted, promoted or produced by Center of Sarasota LLC, are not eligible to receive a refund for any reason, under any circumstance including, but not limited to: injury, scheduling conflict, event delay, event rescheduling or date changes, event modification or event cancellation. The additional online transactional (checkout convenience) fees, donations, spectator tickets, merchandise purchases, applicable taxes, or any other costs incurred in connection with the event are non-refundable under any circumstances. Due to the nature of producing single-day events, we cannot offer refunds for event scheduling changes, postponements, or cancellations due to logistical difficulties or inclement weather.

"Unforeseen circumstances" will not be acceptable grounds for a refund, including but not limited to the following: natural disasters, terrorism, long wait time in lines, medical emergencies, traffic, parking or transportation issues.

"Dissatisfaction" with any aspect of the event is not grounds for a refund, including but not limited to: music, performances, decorations or lack thereof, party favors or lack thereof, beverages or lack thereof, alcohol selection, delays in bar service or waiting in service lines, food availability and selection, fellow patrons/attendees, venue staff, event staff, security, performances, ambiance, amenities, venue, checkin process, seating or lack of seating, emergency closures of event, delayed commencement of event, early ending of event, amenities such as fireworks or public performances or the lack thereof, or visual line of sight to amenities such as fireworks or line of sight being impeded for performances.

The Ticketholder is aware that the venue, programming, and performers are subject to change without notice, which is not grounds for a refund. Ticketholder is aware that amenities included with ticket purchase are not guaranteed and are subject to change at any time, including but not limited to: VIP amenities, drink specials, drink tickets, gifts, express entry, special areas, or celebrity guests. Changes such as those mentioned are not grounds for a refund.

If you purchased a ticket for the incorrect date, time or event, the event Organizer is not obligated to provide a refund, credit, exchange or transfer. If you do not attend the event, you are still 100% financially liable for your purchase. If you cannot attend the event, you will not receive a refund.

**Discount Policy**: All discount vouchers must be redeemed at the time of booking. No refunds will be paid for discounts awarded. If an Event has a deadline and you do not register by the deadline, we are unable to guarantee access. If you do not receive confirmation and you want to make sure you are correctly registered, just call the Organizer for confirmation.
